I, \_\_\_\_\_ and \_\_\_\_\_, understand that horseback riding and other horse-related activities are **INHERENTLY DANGEROUS ACTIVITIES** and in consideration of the general benefits accorded by the Bethany Horsemen and/or the Bethany Horsemen, Inc., (hereinafter collectively referred to as the (“Bethany Horsemen”), in particular the privilege of riding on various privately owned or South Center Connecticut Regional Water Authority (“Authority”) owned properties, I, for myself, my heirs and assigns, do hereby agree to assume the risk of and responsibility for any injury which may occur to me, my family, including my children, or my guests, or damage or injury to my property arising out of such activities.

Specifically, risks inherent to horse related activities include but are not limited to, the possibility of collisions with or caused by other riders and their mounts or other trail users, kicks, collision with natural and manmade obstacles, falls from horses or with horses, carriage accidents, falling objects, low branches, uneven terrain, or holes. Other possible risks include injury or damage from the actions or omissions of other persons, horses or animals, and the negligent failure to guard or warn of a dangerous condition, use, structure or activity.
